

Background and site description	Located halfway between Guildford and Godalming just off the A3100 in Surrey. The 0.2 hectare site is situated within a small industrial complex within wider countryside. The site comprises hard standing with a small area of woodland along the north east boundary and industrial use on all other sides. The wider landscape is a mixture of woodland and agriculture with the Wey Valley Meadows less than 100m to the east.
National Designations (SSSI, SAC, SPAs, RAMSARs and NPs) within 1km	The Wey Valley Meadows SSSI is designated for its unimproved meadows that supports a rich plant community which is indicative of ancient, undisturbed grasslands. Most of the site overlies alluvium deposits from the River Wey's floodplain and this supports swamp and fen meadow as well as neutral and acidic marshy grassland. Other parts of the site are sandy left over from interglacial times and this supports acid grassland communities.
